Expected change in target valuations during the runup (V_R) , throughout the entire bid process (V_P) , and the expected markup $(V_P - V_R)$

Benefit function has target and bidder equally sharing synergy gainss. Bidder bears a larger share of bid costs. Uncertainty in the signal, s, is uniform. Expected markup hits zero when deal is perfectly anticipated.
